Dear Family,

Thank you for your interest in the Beyond the Placement Grant Program. Beyond the Placement is a new program that provides grants to help families adopt waiting children. There are many children available for adoption that are older or have special needs. In helping families reduce the financial barriers, we can help find a waiting child a home. Grants range from \$250 to \$1,000. To qualify for a grant, first you must be active in a New Beginnings program. Next, you must be seeking approval or be approved to adopt a waiting child. Lastly, you must demonstrate financial need. (Along with other considerations, financial need could be demonstrated by a gross household income of less than \$125,000 or special circumstance.)

Grant applications will be reviewed by our Grant Selections Committee. We will make every effort to consider your application promptly. We look to and will try to pre-approve grants early in the process. The Grant Application can be submitted with the Adoptive Family Profile, or any time prior to finalization. Grants will be awarded upon the acceptance of a waiting child for adoption.

Beyond the Placement Grants do not fund the adoption. It can help reduce the cost of adopting a waiting child so you will have a little more money for the trip abroad or the first doctor's visit.
